Sub: Grant of permission for a period not exceeding 05 years to KVG Ayurveda Medical College & Hospital, Ambate Adka Kurunjibag, Sullia T.Q., D.K., Mangalore, Karnataka with 60 seats in UG (BAMS) course and 34 seats in 06 PG courses viz. (i) Dravyaguna Vigyana-06 seats, (ii) Rasa Shastra & Bhaisajya Kalpana-06 seats, (iii) Agad Tantra avum Vidhi Vaidyaka-05 seats, (iv) Kayachikitsa-05 seats, (v) Shalya Tantra-06 seats and (vi) Panchakarma-06 seats under Section 13C/13A of the IMCC Act, 1970 from the academic session 2016-17 to the academic sessions 2020-21 – reg.

Sir,

I am directed to refer to the Ministry's order No.R.17011/56/2015-EP (IM-1) dated 26.08.2015 related to admission matter for the year 2015-16 intimating certain shortcomings for rectification for consideration of the case from the 2016-17 session.

- 2. The CCIM had carried out an inspection of the institution on 05-06.05.2016 to reassess the available facilities of teaching and practical training as well as to verify the compliance submitted by the college and forwarded its recommendations and report to this Ministry.
- 3. The recommendations and visitation report of the CCIM have been carefully examined in terms of the "Indian Medicine Central Council (Minimum Standard Requirements of Ayurveda Colleges and attached Hospitals) Regulations, 2012 read with amendment Regulations of 2013, provisions under the IMCC Act, 1970, relevant regulations made thereunder and as per approval of the Hon'ble MoS (IC) for the UG/PG

Course for grant of conditional permission for the academic session2016-17 vide Ministry's letter No.R.11011/01/2016-EP (IM-1) dated 12.08.2016 & 31.08.2016 (available at Ministry's website <indianmedicine.nic.in>) and it is found that the College is fulfilling the notified and approved criteria as follows:-

Teachers:

- a. For UG course: 100% eligible teachers, 15 Higher Faculties (Professor/Reader) in 14 Departments in the college, 1P/R + 1L in each of 13 Dept. & 1P+1R+1L in Kayachikitsa and 1L of Sanskrit for upto 60 UG seats and 09 part time teachers;
- b. For PG course(s): In addition to the UG course, 1 Higher Faculty + 1 Lecturer in the concerned PG department, fulfillment of teacher-student ratio (1:3 for Professor, 1:2 for Reader and 1:1 for Lecturer);

(ii) Beds in hospital:

- a. Minimum 60 beds in hospital for upto 60 intake capacity in UG course;
- b. Minimum 100 bedded hospital for PG Colleges of Ayurveda and additional beds in 1:4 student-bed ratio for each PG clinical seat over the total requirement of beds for UG students intake capacity;
- Minimum 120 patients per day in OPD during the year 2015 for upto 60 UG seats;
- (iv) 40% bed occupancy for UG College and 50% for Colleges with PG course/s in IPD during the year 2015;
 - (v) Equipment and instruments: Minimum 90% of required equipment as specified under the schedule VII of MSR;
 - (vi) Fulfillment of provisions including staff requirement under relevant PG Education Regulations; and
 - (vii) Other infrastructure and staff required as per the MSR Regulations of 2012 read with amendment Regulations of 2013, in addition to above requirements for grant of permission for a period not exceeding five years.
 - It has, therefore, been decided by the Central Government to grant permission under section 13C/13A of the IMCC Act, 1970 for a period not exceeding five years to the KVG Ayurveda Medical College & Hospital, Ambate Adka, Kurunjibag, Sullia T.Q., D.K., Mangalore, Karnataka with 60 seats in UG (BAMS) course and 06 PG courses namely (i) Dravyaguna Vigyana-06 seats, (ii) Rasa Shastra & Bhaisajya Kalpana-06 seats, (iii) Agad Tantra avum Vidhi Vaidyaka-05 seats, (iv) Kayachikitsa-05 seats, (v) Shalya Tantra-06 seats and (vi) Panchakarma-06 seats(the seats in the said PG courses will be subjected to the availability of eligible PG teachers for PG in concerned Department as per PG regulations) from the academic session 2016-17 to the academic session 2020-21 with following instructions: Hog 13.10.16 Page 2 of 3

- i. that the college shall obtain the NABH accreditation for the Hospital within one year and the NAAC accreditation for the College within two years from the issuance of the permission letter and the college shall submit its compliance to this Ministry as well as to the CCIM within specified period, failing which the permission granted for a period not exceeding 5 years shall deem to be withdrawn; and
- that as specified in Sub-Regulation (2) of Regulation 3 of the Regulations namely the Indian Medicine Central Council (Minimum Standard Requirements of Ayurveda Colleges and attached Hospitals) Regulations, 2012 read with amendment Regulations of 2013 ".....during which the college shall not be inspected, except for random checks on receipt of any complaint, or otherwise as deemed necessary either by the Central Government or by the Central Council of Indian Medicine. The Central Council shall visit the college suo moto three months before the expiry of permission".
- The college shall maintain all the Requirements of infrastructure and teaching & training facilities as specified in the Indian Medicine Central Council (Minimum Standard Requirements of Ayurveda Colleges and attached Hospitals) Regulations, 2012 read with amendment Regulations, 2013, provisions of the IMCC Act, 1970 and relevant Regulations made thereunder in toto during the period of permission (i.e. up to 2020-21). As per the provisions of Sub-Regulation (2) of Regulation 3 of the MSR Regulations, 2012, the Central Council shall visit the college *suo moto* three months before the expiry of permission to verify the requisite infrastructure and facilities required under above mentioned Regulations by means of an inspection and shall submit a report to the Ministry of AYUSH for considering the permission matter from the academic session 2021-22.

Sub: Matter related to grant of permission to the President, Academy of Liberal Education (Regd.), Ambatedka, Kurunjibag, Sullia, D.K., Karnataka to increase the admission capacity from 60 to 100 seats in existing UG (BAMS) course at KVG Ayurveda Medical College & Hospital, Ambate Adka Kurunjibag, Sullia T.Q., D.K., Mangalore, Karnataka from the academic session 2016-2017 to the academic session 2020-21 under Section 13A of the IMCC Act, 1970 - Letter of Permission - regarding.

Sir.

In continuation to the Ministry's letter of even No. dated 09.03.2016 wherein a Letter of Intent was issued to the college with respect to the proposal submitted to the Central Government as cited above, the CCIM had carried out an inspection of the institution on 05-06.05.2016 to reassess the available facilities of teaching and practical training as well as to verify the compliance submitted by the college and forwarded its recommendations and report to this Ministry. On examining the same, it was observed that the required number of 1LF and 1HF (Reader) in the department of Ayurved Samhita & Siddhant were not available in the college as per MSR. Therefore, under provisions of the first proviso to sub-section (5) of Section 13A of the IMCC Act, 1970, an opportunity of hearing was granted to the college on 15.11,2016 to present the case.

2. The observation of hearing Committee based on submission made by the college representative during hearing and an undertaking furnished by college representative on Non-Judicial Stamp of Rs.100/- with assurance to fulfil the vacancy of Reader in the department of Ayurved Samhita & Siddhant within 31.12.2016 and recommendations & visitation report of the CCIM have been carefully examined in terms of the provisions of the IMCC Act, 1970 and relevant regulations made thereunder and approved norms for academic session 2016-17,

which were circulated vide Ministry's letter no. R.11011/01/2016-EP (IM-1) dated 12.08.2016 & 31.08.2016 (available on Ministry's website <www.ayush.gov.in>); permission of the Central Government is hereby granted to the President, Academy of Liberal Education (Regd.), Ambatedka, Kurunjibag, Sullia, D.K., Karnataka to increase the admission capacity from 60 to 100 seats in existing UG (BAMS) course at KVG Ayurveda Medical College & Hospital, Ambate Adka Kurunjibag, Sullia T.Q., D.K., Mangalore, Karnataka from the academic session 2016-2017 to the academic session 2020-21 under Section 13A of the IMCC Act, 1970. Therefore, the college may take admission to increase UG admission capacity from 60 to 100 seats (40 additional UG seats) in existing UG (BAMS) course along with already permitted UG and PG courses from the academic session 2016-17 to the academic session 2020-21 subject to the condition that the college shall obtain the NABH accreditation for the Hospital within one year and the NAAC accreditation for the College within two years from the issuance of the one year and the NAAC accreditation for the College within two years from the issuance of the permission letter and the college shall submit its compliance to this Ministry as well as to the CCIM within specified period, failing which the permission granted for a period not exceeding 5 years shall deem to be withdrawn, other condition will be the same as informed earlier vide Ministry letter No.R.17011/56/2016-EP (IM-1) dated 13.10.2016.

- 3. This permission for increase in admission capacity in existing UG (BAMS) course from 60 to 100 seats as mentioned above for the first admitted batch of 2016-17 session, will be valid till such time as the first batch of students admitted against these courses appear for the first final examination of the said courses and at that time, the College authorities may take up the matter for recognition of the qualifications under Section 14(2) of the IMCC Act, 1970.
- 4. The college administration will ensure that sufficient qualified teachers, as prescribed in the relevant CCIM Regulations, are in position before the admission of the students in the above-mentioned course is made, under intimation to the Central Government and CCIM.
- 5. Further, to obtain permission from the academic session 2021-22 onwards and to take admissions in the above said courses, the college shall maintain all the requirements of infrastructure and teaching & training facilities as specified in the Indian Medicine Central Council (Minimum Standard Requirement of Ayurveda Colleges and attached Hospital) Regulations, 2012 read with amendment Regulations of 2013, provisions of the IMCC Act, 1970 and relevant Regulations made thereunder in toto during the period of permission (i.e. up to 2020-21) as intimated by the Ministry vide letter No.R.17011/56/2016-EP (IM-1) dated 13.10.2016, which may be verified either by the Central Government or by the Central Council of Indian Medicine on receipt of any complaint. Further, as per the provisions of Sub-Regulation (2) of Regulation 3 of the MSR Regulations, 2012, the Central Council shall visit the college
